A diagnosis of clinically significant hypervolemic or euvolemic hyponatremia (serum sodium &lt; 130mEq/L prior to initiation of therapy); <b>AND</b></li> <li>2. Member has not responded to fluid restriction; <b>AND</b></li> <li>3. Samsca (tolvaptan) therapy has been initiated or reinitiated in the hospital within the last 30 days (hospital record must be provided).</li> </ol>
